**Political Science Internship (1-6 hours).** Supervised field experience with a government organization or agency. Beyond submission of completed work assignments and time log, an additional written paper and/or oral presentation may be required depending on the nature of the field experience and the amount of credit requested. Course may be repeated to a maximum of six semester hours. PR: POSC 200 or POSC 210, POSC 218, and consent of instructor

<u>Grading Policy:</u> 50% for Research paper based upon your overall legislative experience, and 50% based upon a Log you must keep of your daily activities in the legislature.

<u>Grading Scale:</u> 90-100=A; 80-89=B; 70-79=C; 60-69=D; 0-59=F. These numerical scores correspond to the following evaluations: "A" = Excellent; "B" = Good; "C" = Satisfactory (NOTE: A grade of "C" or better is required in major courses); "D" = Poor (passing, except in major courses); "F" = Earned Failure (removed only by repeating the course; upon successfully passing the course, the first grade is "excluded" from grade point average. The second grade is "included" in the recalculation of the grade point average); and "I" = Incomplete.
